This grant program and publication are funded in full by the California Department of Forestry and Fire Protection (CAL FIRE) as part of the California Climate Investments Program.

California Fire Safe Council (CFSC) is pleased to announce that 11 California counties have been selected to receive grant awards for evacuation planning and development projects. With funding from a 2022 CAL FIRE master grant, the CFSC will award more than \$3.3 million to these 11 applicants through the Evacuation Planning and Development Grant Program.

The objective of the grant program is to support counties with evacuation route identification, planning, fuel reduction, maintenance and signage for use during emergencies. Funding can also be used for public education activities that increase community awareness of evacuation planning and preparation. The selected counties have been approved for funding for activities conducted between September 1, 2022 through February 29, 2024.

Counties will work closely with the CFSC to identify, document, and maintain evacuation routes in their communities, as well as develop mechanisms to improve evacuation education, outreach and coordination efforts.

We look forward to working with the award recipients to enhance each county's wildfire resilience through evacuation planning, while working toward our shared vision of a more fire-resilient California!

The county will use this grant, in conjunction with a FEMA HMGP grant as part of the local match, to provide the ancillary services necessary to support the overall outdoor, broadcast, and online alert system.

San Luis Obispo County is working collectively with all jurisdictions to create a county-wide evacuation plan. This grant will support the use of ZoneHaven to develop evacuation zones and routes throughout the county. Zones will be incorporated into Wireless Emergency Alerts, Reverse 9-1-1, as well as integrated with maps used in the Wildland Pre-Attack Plans. These tools will be used by Authorities Having Jurisdiction (AHJ's), Office of Emergency Services (OES), and the media to conduct evacuations.

Stanislaus County will develop evacuation routes in the Western portion of Stanislaus County, an area of High Fire Hazard Severity. Because the proposed project area has only one road in and out of the community, the County will utilize grant funds to research, plan and develop evacuation routes that would support evacuations that must travel through State Responsibility Area lands held by private property owners. The County will work with partners and local landowners to plan and establish these evacuation routes.


